I. BACKGROUND

CP2 (Actuarial Modelling) examination appears as a challenge to many students due to its unique nature in respect of modelling skill requirements. In most of the cases, students failed to understand the strategical approach for such a different examination. By offering a guidance and support program for the subject, the IAI makes an attempt to help out students who are in need.

The objective of the program is to engage candidates to practice and to enhance their confidence by identifying own strengths and weaknesses. The program includes, evaluation and discussion on performance of 3 sample tests by anonymously swapping answer scripts of participants and also by the faculty.
