Online registrations for ACET (Actuarial Common Entrance Test) October 2024 will open on 20<sup>th</sup> September 2024 at 3.00 pm and close on 5<sup>th</sup> October 2024 at 6.00 pm.

<b>Date of results</b>	<b>18<sup>th</sup> October 2024</b>

### **Note:**

- 1. Candidates who pass the ACET in October 2024 will be provided an exclusive window to register for November 2024 Actuarial examination.**
- 2. The registration fee for ACET October 2024 is Rs. 500.**

### **Eligibility Criteria:**

- Students who have appeared 10+2 or an equivalent examination and awaiting results.
- A candidate who has passed 10+2 or any other higher courses/examinations.
- Any candidate studying higher courses/examinations.

### **Procedure for Online Registration:**

- 3) Log in to your ACET login [Click here](#) by entering your login ID and Password.
- 4) Click on the "Registration form" tab-> fill in your personal details-> Confirm & Next.
- 5) Education Details->Click on "Add Educational details"-> Enter 10<sup>th</sup> grade info ->Save.  
(Follow the same process for 12<sup>th</sup> grade)->Confirm and Next.
- 6) Select "State" and "City" -> Confirm & Next.
- 7) Read the Declaration -> Click on "I Accept".
- 8) "Pay" the examination fees.
- 9) Students are advised to use desktop/ laptop for registration. Please do not use Mobile phone for the purpose.
- 10) It is mandatory to upload your passport size photograph as per the mentioned specification.

Do's	Don'ts
Upload your recent standard passport size photograph (4.5 cm length x 3.5 cm width) in colour	Do not upload black and white photographs
Background of the photograph should be plain white, and the dress should be in dark colour	Photograph with dark background or in uniform, or with eyes hidden under coloured or dark glasses will not be accepted
Photograph should fit within the given box	Photograph is NOT to be signed
Frontal view of the full face should be visible in the photograph	Distracting shadows on the face or on the background should not be there
Print of the photograph should be clear and with a continuous-tone quality	Eyes must not be covered by hair.
Expression of the face should be natural (no grinning, frowning or raised eyebrows)	Glares on eyeglasses should be avoided with a slight upward or downward tilt of the head
Eyes must be open and both edges of face must be clearly visible	Photograph should not be damaged, for example: torn, creased, or marked
Minimum photo resolution should be of 150px *150px. Maximum photo size should not be more than 1MB to be saved only in (.png, .jpg, .bmp, .jpeg, .gif, .raw) format	Head coverings are not permitted except for religious reasons, but the facial features from bottom of chin to top of forehead and both edges of the face must be clearly visible
Head should be in the center of the frame and both ears should be visible	Photographs cut from group photographs are not acceptable

- 11) Overseas students: Overseas Students appearing for ACET October 2024 can register; except the below mentioned countries:  
Russia, Cuba, Iran, North Korea, and Syria
- 12) After successful registration, you will be able to download the Welcome Kit of one Sample Question Paper, Indicative Solution from your ACET login Welcome kit tab.
- 13) Institute will issue the "**Student Guide for ACET October 2024 Home Based Online Examination**" for detailed 'know how' of the online examination shortly.
- 14) All examination related details will be available in your ACET Login and will also be communicated on your registered email ID at least 2 days before the date of examination.
