## **Procedure for Challenge of Indicative Solution**

### **Objective:**

This procedure underscores our unwavering commitment towards complete transparency, probity and prompt redressal in the examinations conducted at IAI. The terms and conditions herein enable candidates challenge inconsistencies/ infirmities in matters pertinent to Indicative solutions prepared as responses to examination Questions.

### **Timeline:**

Students will receive Indicative solutions to their exams promptly within one working day of the last actuarial exam. Any IAI member desirous of contesting or challenging the indicative solutions published, can do so within seven days of indicative solutions being released. Challenges submitted after the seven-day window shall not be accepted. The stringent timeline is mandatory to ensure efficient and fair challenge process and prompt closure.

### **Submission Process:**

Challenges must be submitted formally through the respective member login or IAI website after paying the prescribed fees as mentioned below. The challenge must unambiguously furnish references or workings showing reasonable cause as to why an indicative solution is deemed incorrect. Inadequately backed up challenges lacking credible evidence shall be rejected summarily as this is vital to the integrity and maturity of the challenge process.

### **Supporting Evidence:**

The supporting evidence may include references to textbooks, lecture notes, or other pertinent course materials that substantiate the basis of their challenge. Additionally, candidates must clearly back their assertions on specific flaws, errors, or discrepancies in the indicative solution with supporting evidence provided.

### **Communication of Decision:**

The decision of the review group will be communicated to the candidate within 10 to 14 days after the conclusion of the challenge window. This demonstrates earnest commitment of the Institute to maintain clear and open lines of communication with its students.

**Note:** Any extension in timelines due to unavoidable scenario(s) shall be notified by IAI accordingly.
