This provision applies **only** to CB series, CP1, CP3, SP and SA series subjects, as the results for these subjects have already been released.

**Note:** Subject(s) containing Paper A and Paper B shall be considered as single subject.

- 1. Release of Answer script(s):** Institute will provide unmarked answer script/s. Answer script(s) will be available in member login within 3 working days of last date of application.
- 2. Release of Marksheet(s):** Institute will provide question-wise marks scored in respective subjects. Mark sheet(s) will be available in member login within 3 working days of last date of application.
- 3. Verification of Answer script(s):** The process of verification of answer script covers the following checks.
  - Whether the answer script(s) compilation is complete.
  - Whether any question or part thereof has remained unvalued/unmarked.
  - Whether there is any mark(s) calculation error in any question or total mark(s).
