- Members of the IAI Council, Section 21 and Section 26 Committee members, members of the current GCA working group, and IAI staff are ineligible to participate.
- Any IAI member who has been found guilty by the Disciplinary Committee is not allowed to submit an entry.
- Submissions from non-members are welcome.
