



Institute and Faculty of Actuaries (IFoA) – Chartered Enterprise Risk Actuary (CERA) Seminar - Registration announcement – March 2015

How to obtain the CERA qualification?

The members of the Institute of Actuaries of India can be eligible to receive the CERA qualification in the following way:

1. Become a fellow and have passed ST9 as one of your ST subjects for Fellowship or Fellow members not having ST9 as one of your ST subjects then pass ST9 as an additional ST subject.
2. Attend and successfully complete CERA seminar.

Currently, CERA Seminars offered by **the Institute and Faculty of Actuaries** and **the Institute of Actuaries of Australia** are eligible for CERA qualification.

What are the eligibility criteria to attend CERA seminar conducted by IFoA?

Candidates who are current members of the Institute of Actuaries India (IAI) can register for the IFoA CERA seminar if they have passed or hold an exemption for ST9.

The CERA seminar is held four times a year, usually in March, June, October and December.

What's involved in the seminar?

➤ Before the seminar you will need to do some preparation work:

- calculations for a team presentation
- reading for a governance case study
- preparation for a debate

You will be sent a pre-seminar workbook giving full details of what is needed.

➤ On the day of the seminar you will:

- take an active part in discussion, lively debates and case studies
- have the opportunity to meet and talk to senior risk officers
- build on the pre-seminar work that you will have done
- undertake challenging and thought provoking team exercises

Before joining the seminar you will be put in touch with your allocated team members using an online community on the website where you can get to know each other, and also discuss the preparatory work you have done.

Fees

The fee for the CERA seminar is Rs. 45000.

Below is the procedure for the online registration of examination:

- 1) Log on to your member login (www.actuariesindia.org) by entering your login ID and Password.
- 2) Click on the “Seminar” tab.
- 3) Select the dietary requirement as per your wish to select “Veg” Or “Non-Veg”.
- 4) Select Seminar as “CERA”
- 5) Click on “Pay” tab to make the payment of Seminar fees.
- 6) On successful payment you will be directed towards “Transaction Acknowledgment” page.

Points to Remember

- 1) CERA Seminar is held on 19th March 2015 in London.
- 2) Online Registration starts on 12th December 2014, Friday at 2.00 p.m.
- 3) Last date of Registration is 30th December 2014, Tuesday at 2.00 p.m.
- 4) Confirmation of seminar registration will be sent via email by 04th week of January.
- 5) Candidates will be contacted directly via email with the pre exam workbook and venue information 4 weeks before the seminar.
- 6) Candidates must submit their pre-seminar workbook and participate in the relevant group chats as per the advertised deadlines; non compliance will result in the candidate being removed from the seminar.
