#### 5. POINTS TO NOTE:

- **a.** Application should be in the prescribed form only.
- b. Last date of receipt of application is 10<sup>th</sup> February 2015. Any application received after this date will not be considered.
- c. Candidates will be issued with an exam entry permit by IFoA shortly before the exam date which is the ticket for entry to the exam. The exam entry permit will provide confirmation of exam entry and centre location, as well as showing the candidate number which will be needed for the exam. Candidates are advised to check their exam entry permit thoroughly upon receipt so that any errors may be rectified in good time.
- **d.** The exam entry permit will be sent to the address mentioned in Examination Form. These contact details will also be used to let candidates know if there are any changes to the exam venue or timings, so candidates are strongly advised to ensure that these details are correct.
- e. If the exam entry permit has not been received ten days before the exam date, candidates should contact the Exams Team at examinations@actuaries.org.uk to arrange for another copy to be sent. Candidates are asked to allow two working days for such requests to be actioned as the exam entry period is a busy time for the Exams Team.
- f. Institute has issued photo identity card to all student members. This is a compulsory identification for attendance. Kindly carry the same during the examination. If you have not received the same, kindly contact Ms. Bhakti at courier@actuariesindia.org
