- 5) It is mandatory to upload your passport size photograph as per the mentioned specification. You will receive a confirmation email, in case your uploaded photograph is up to the mark, else you will be receiving a rejection email asking you to re-upload.

- 7) On filling up the Online Registration Form, you will receive a confirmation mail at your registered email id giving you the link to proceed further by giving other details, uploading your photograph and making payment of registration fees by Debit or Credit Card or Internet Banking.
