## Subject: IAI Education Curriculum 2019 (version 1.00/12 10 2019)

This is with reference to the following;

- 1) IAI Education Curriculum 2019 (version 1.00/12 10 2019) and
- 2) IAI announcement dated 22nd October, 2019 on above subject

In a nutshell, the above documents provides for the following;

- 1. The examinations to be cleared to qualify as Fellow Member of IAI.
- 2. Transfer arrangement from the curriculum prior to 2019 to the new curriculum 2019
- 3. Defines the assessment criterion for a Fellow Member of IAI to be taken as Passed in the respective Specialization Subject i.e. Specialist Application or Specialist Advanced Subject as prescribed by IAI can be applicable for:
  - a. who have cleared Specialist Application/Specialist Advanced in one subject area from IAI but have significant amount of Indian Specific experience in other subject area [For example, cleared SA6 as prescribed by IAI and having Indian Experience in Life insurance]
  - b. who have cleared Specialist Application/Specialist Advanced in one subject area which is not Prescribed by IAI but have significant amount of Indian experience in same subject Area [For example, cleared SA2 from Other Institute i.e. not as prescribed by IAI and having Indian Experience in Life insurance]
  - c. who have cleared Specialist Application/Specialist Advanced in one subject area which is not Prescribed by IAI but have significant amount of Indian experience in other subject Area [For example, cleared SA2 from Other Institute i.e. not as prescribed by IAI and having Indian Experience in Life insurance]

All Fellow Members of IAI, who satisfies the criterion of assessment to be taken as Pass in the respective Specialist Application or Specialist Advanced Subject as prescribed by IAI as per clause 8.1 (b) and (c) of IAI Education Curriculum 2019 (version 1.00/12 10 2019), may apply in the prescribed application form (<u>http://www.actuariesindia.org/downloads/Application%20form%20-%20Specialist%20Advanced%20Subject 22102019.docx</u>) along with the required documents and requisite fee for the assessment to the Executive Director at ed@actuariesindia.org with hard copy of the documents to be sent by courier to IAI Office.

IAI will declare results periodically for the respective Specialization Subject i.e. Specialist Application or Specialist Advanced Subject as prescribed by IAI for all Fellows who satisfies the criteria of assessment of total years of experience and India specific post qualification experience on the subject.
