 Review of GN on PF in conjunction with feedback of chartered accountants. Had initial Meeting with ICAI representative. 	Discuss about current issues and practices in Actuarial Valuation of PF Interest rate guarantee. It was proposed to prepare a whitepaper covering various challenges and best possible methodology on this topic and present same to ICAI.
