## Webinar in IFRS 17: Impact of IFRS 17 on Product Design and Pricing

The Institute of Actuaries of India (IAI) is pleased to announce a webinar hosted by the Advisory Group on IFRS 17 (IND AS 117).

IFRS 17 represents a fundamental change in accounting rules, and insurers may be unsure of how, or even whether, their product pricing and design may change as a result. Furthermore, it is likely that companies will want to start thinking already about how the products that they are selling or launching will look under the new accounting regime.

Commentators to date have expressed varying opinions on this. This webinar will includes worked examples to illustrate key themes. It should be of interest to senior management and others within insurance companies who may be involved with strategic decision-making and product development.

The scope of this analysis focuses principally on European countries that have adopted Solvency II, however, the concepts under consideration are likely to be applicable to other markets outside Europe. The webinar will also include discussion of how the conclusions can be applied to India, in particular.
