Introduction:

During last year there has been many initiatives taken by the insurance regulator (IRDAI) in consultation with the Insurance industry intended at enhancing accessibility and affordability of Insurance in India with an ultimate aim of increasing the insurance penetration. Increasing the penetration of general insurance products may require many initiatives aimed at various stakeholders.

This webinar will focus on 3 important regulatory initiatives namely:

- 1) Draft "Expenses of Management" regulation
- 2) International Financial Reporting Standard 17
- 3) Risk based capital

The draft "Expenses of Management" is aimed at providing flexibility to the insurance companies in its operation, while IFRS 17 and risk-based capital provides a framework of reporting and solvency assessment which is globally accepted. These in turn will help improve transparency, comparability, risk-management, and facilitate cross border-investments thus again helping to increase penetration.
